The Victorian Curriculum and Assessment Authority (VCAA) is a statutory authority continued under the *Education and Training Reform Act 2006* (Vic). The VCAA collects the information requested in this form, which includes personal information within the meaning of the *Privacy and Data Protection Act 2014* (Vic) and may also include personal and health information within the meaning of the *Health Records Act 2001* (Vic), for the purpose of facilitating an application for a Statement of Study Score, Statement of Examination Marks, Statement of General Achievement Test (GAT) Marks, Inspection of Examination Response Materials and/or to listen to a recording of your Music Performance Examination. The personal and/or health information collected in this form will be disclosed to and used by relevant VCAA employees and/or contractors for and in connection with the above mentioned purpose. The personal and/or health information collected will not otherwise be used or disclosed by the VCAA, except with the consent of the individual, or if the VCAA is required or otherwise permitted by law to do so. Statement of Study Score

This shows your specific graded assessment scores and explains how your study score was calculated. There is no fee to obtain a Statement of Study Score.

Statement of Examination Marks

This shows the mark you received for each question or criterion on the examination and the maximum mark obtainable. It also contains the range of scores that correspond to the grade you received. There is no fee to obtain a Statement of Marks.

Statement of General Achievement Test (GAT) Marks

This shows the correct response and your response to each multiple-choice question, your total mark for each multiple-choice component and your mark for the written components.

There is no fee to obtain a Statement of General Achievement Test (GAT) Marks.

Inspection of Examination Response Materials

You may inspect your written examination response materials including the GAT or listen to an audio recording of your Music performance examination. Inspections are not available for any Dance, Drama and Theatre Studies performance examinations, VCE Languages oral examinations and the VCE Extended Investigation oral presentation. Audiovisual recordings are not available for any examination.

Inspections should take place at your school with the principal's permission. The examination response material(s) will be sent securely via email to the principal. You will need to make an appointment with the school for the inspection.

When schools are closed, inspections may take place at the VCAA by appointment.

Before an inspection you must obtain the relevant Statement of Marks.

VCE examination response materials do not contain any assessor's marks or comments and remain the property of the VCAA.

The VCAA recommends that your subject teacher be present when inspecting the examination response material(s). If your teacher is not available, you should contact your school to discuss the possibility of a suitable substitute. The substitute should be a teacher who is teaching the study at the same level.

There is a fee of \$26.35 per examination.

The duration of the inspection is between 15 and 30 minutes per examination.

In exceptional cases, where it can be demonstrated that a clear error has occurred in the assessment of a question(s) on a written examination, the VCAA may consider a VCE Examination Score Review Application, which must be made by your school principal and supported by your subject teacher. To be considered by the VCAA, the application must comply with the guidelines that are available to schools.

There is no provision for late applications. Applications received after this date will not be processed.
