



# VCE VET Music: Sound Production

## Aural and written examination – End of year

### Examination specifications

#### Overall conditions

The examination will be sat at a time and date to be set annually by the Victorian Curriculum and Assessment Authority (VCAA). [VCAA examination rules](#) will apply.

There will be 15 minutes of reading time and 1 hour and 30 minutes of writing time.

The examination will be assessed by a panel appointed by the VCAA.

The examination will contribute 34 per cent to the study score.

#### Content

The VCE VET Music: Sound Production examination will be based on the following compulsory units of competency from Units 3 and 4:

• CUASOU306	Operate sound reinforcement systems	Release 1	40 hours
• CUASOU317	Record and mix basic music demos	Release 1	40 hours
• CUASOU308	Install and disassemble audio equipment	Release 2	40 hours
• CUASOU321	Mix music in studio environments	Release 1	60 hours
• CUASOU412	Manage audio input sources	Release 1	30 hours

The weighting of marks on the examination will approximately reflect the proportion of nominal delivery hours of each unit of competency that is examinable for this program.

The examination will focus on an understanding of the performance and knowledge evidence, as described in the elements and performance criteria, and the assessment conditions set out in the assessment requirements document for each unit of competency.

Foundation skills are incorporated in the performance criteria that are required for competent performance.

## Format

The examination will be in the form of a question and answer book.

The examination will consist of two sections.

**Section A** will consist of short-answer and extended-answer questions that may include multiple parts, and will be worth a total of 25 marks. Questions will be related to audio excerpts recorded on a compact disc. The recording will run continuously throughout Section A.

**Section B** will consist of short-answer and extended-answer questions that may include multiple parts, and will be worth a total of 75 marks.

Individual questions may address more than one unit of competency.

All questions will be compulsory. The total marks for the examination will be 100.

Answers are to be recorded in the spaces provided in the question and answer book.
