# Introduction

## Insight Assessment Platform user guides

The following user guides are available for non-government schools to learn more about using the Insight Assessment Platform:

1. Technical Support Staff User Guide
2. School Assessment Administrator User Guide
3. Assessment delivery guide.

## About the Insight Assessment Platform

The Insight Assessment Platform (Insight) is aimed at helping teachers assess the progress of all learners and to support more targeted teaching practices.

Insight has been run by the VCAA since August 2017. It provides a collection of quality online assessment instruments. It supports high-quality assessment practices and provides teachers with specific information to target the learning needs of students through its powerful data analytics and reporting capabilities. Students' assessment data can be reviewed by teachers for diagnostic, formative and summative purposes.

## About this user guide

This document provides non-government School Administrators and Teachers with information and support to enable the use of the online Transition Learning and Development Statement (TLDS) functionality within the Insight Assessment Platform.

## About TLDS

A child's TLDS is completed by their early childhood centre, with contributions from the child and their parents/guardians. A TLDS summarises a child's abilities as they start school and identifies their individual approaches to learning. Section 1.2 of the TLDS provides additional information about children with an identified disability or developmental delay.

The information in the TLDS aims to assist Prep teachers in understanding the needs of the children entering their class, and plan appropriate learning and teaching programs.

## About the Online TLDS

The Online TLDS is a tool for writing and sharing TLDSs. This tool is available for use via Insight.

The Online TLDS has been designed for early childhood services to complete students' TLDS and share them with schools nominated by parents/guardians via Insight.

Sharing a TLDS via Insight will give schools the ability to link a student's TLDS to their individual student record, along with other student assessment data that is held on Insight.

Once a TLDS is linked to a student's individual student record it can follow the student between schools within the same sector.

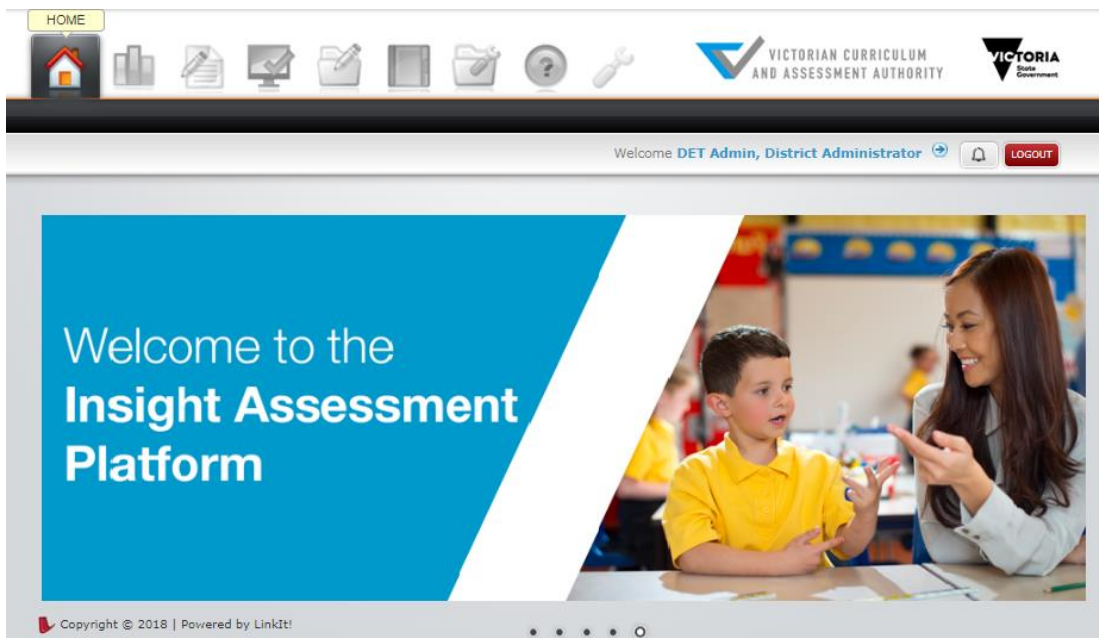

## Section 2 – TLDS for Insight School Administrators

### Notifications

When an early childhood service completes a TLDS on Insight, they are able to submit it via Insight to a school nominated by the student’s parents/guardians. When an early childhood service submits a statement to your school, all Insight School Administrators at the school will receive an email notification to the effect of:

*A Transition Learning & Development Statement (TLDS) for [student’s name] has been submitted through the Insight Platform to [school name].*

**Note:** Please ensure the School Administrators registered at your school on the Insight Assessment Platform are up to date to prevent incorrect members of staff receiving these notifications.

### Accessing TLDS

The TLDS system is located on the **TLDS Manager** page of Insight. Accessing this page will allow you to see all TLDSs that have been sent to your school.

To access the **TLDS Manager**:

1. Select **Reporting**, as shown in Figure 2.0.
2. Select **TLDS Manager**, as shown in Figure 2.0.

TLDSs will be shown in your school’s **TLDS Manager** when:

- TLDSs are submitted to your school from an early childhood centre
- An Insight School Administrator uploads a TLDS that is received via email or in hard copy from the early childhood service or from the student’s family.

## Manually uploading a TLDS

TLDSs that are submitted to your school via Insight will be shown in your **TLDS Manager**. If your school receives a TLDS from a student’s early childhood centre or parents/guardians via email or as a hard copy, it can be manually uploaded to the **TLDS Manager** as a PDF.

To manually upload a TLDS:

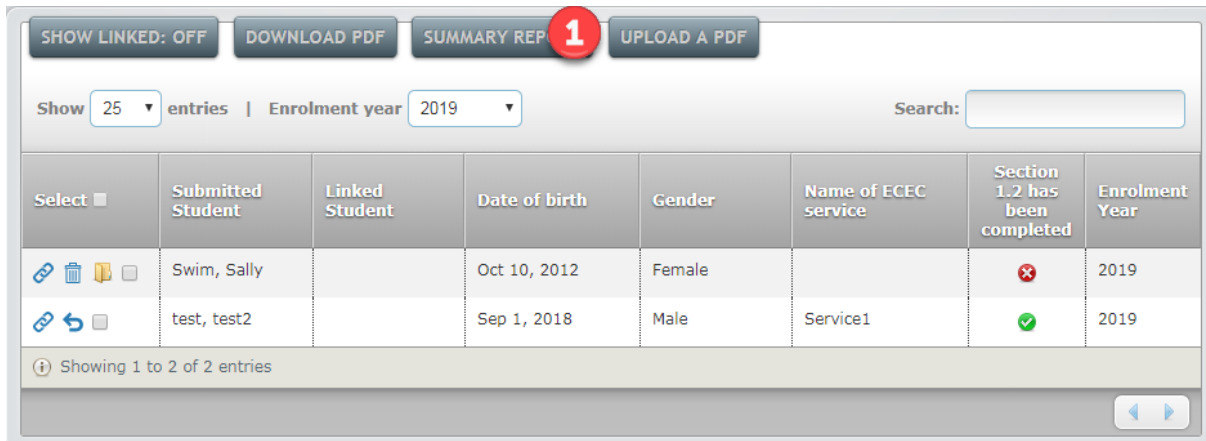

1. Select upload a PDF, as shown in Figure 2.1.
2. The **Upload a PDF** pop-up box will appear. Input the known details of the student on this screen.

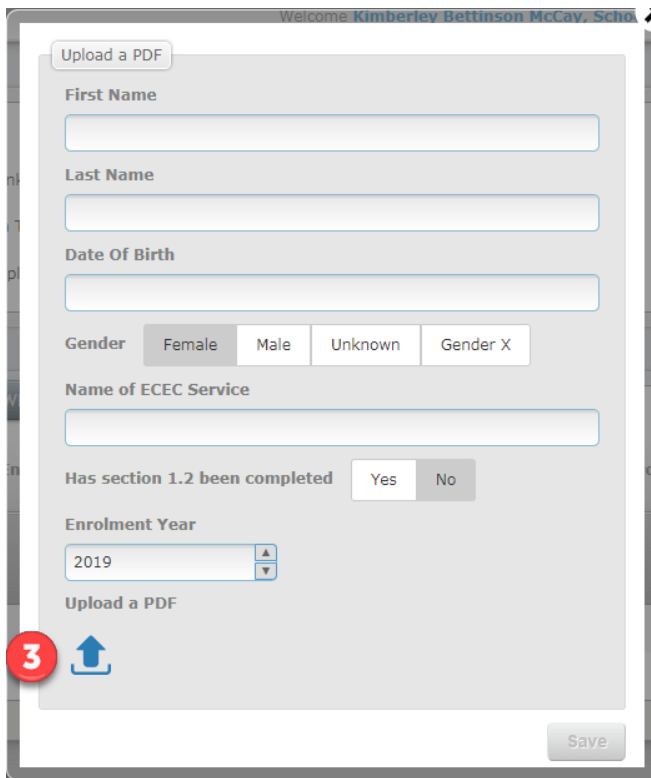

3. Select **Upload a PDF** button to upload the students PDF, as shown in Figure 2.2. A window will open to select the file from your computer. Once you have found the correct file, select **Open**.

4. The selected file name should now be visible in the **Upload a PDF** pop-up box, as shown in Figure 2.3.
5. Select **Save**. The student's details will now be visible in the **TLDS Manager**, as shown in Figure 2.3.

## Linking a TLDS

TLDSs that are sent to your school via Insight, or manually uploaded to Insight, are required to be linked to a student's Insight profile to enable the student's classroom teacher to access the statement via Insight. All unlinked statements are only visible to Insight School Administrators.

To link a TLDS to a student's Insight profile:

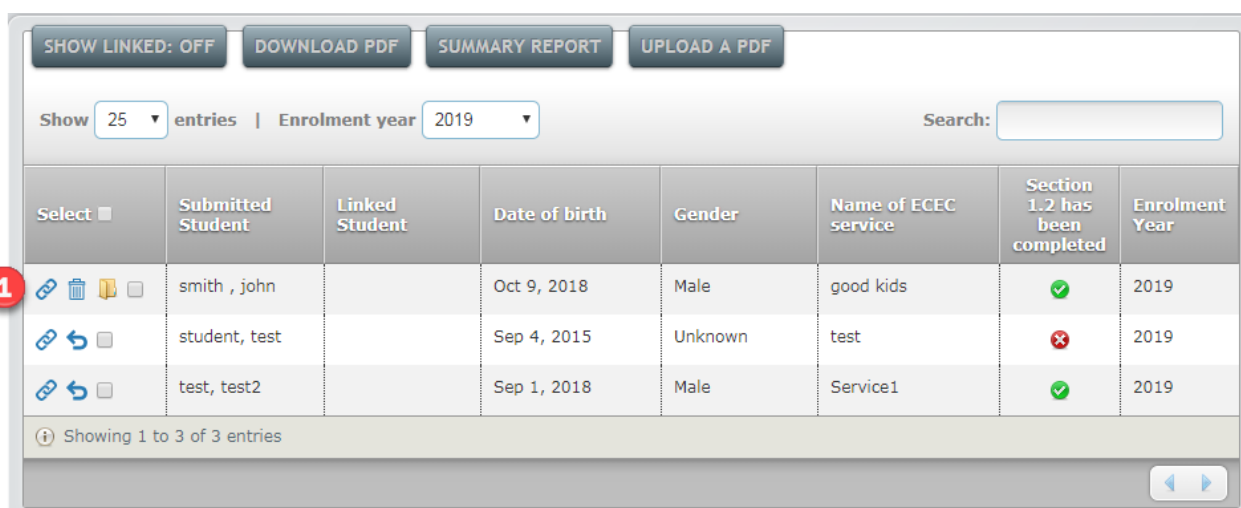

1. In the **TLDS Manager**, select the **link** button as shown in Figure 2.4.

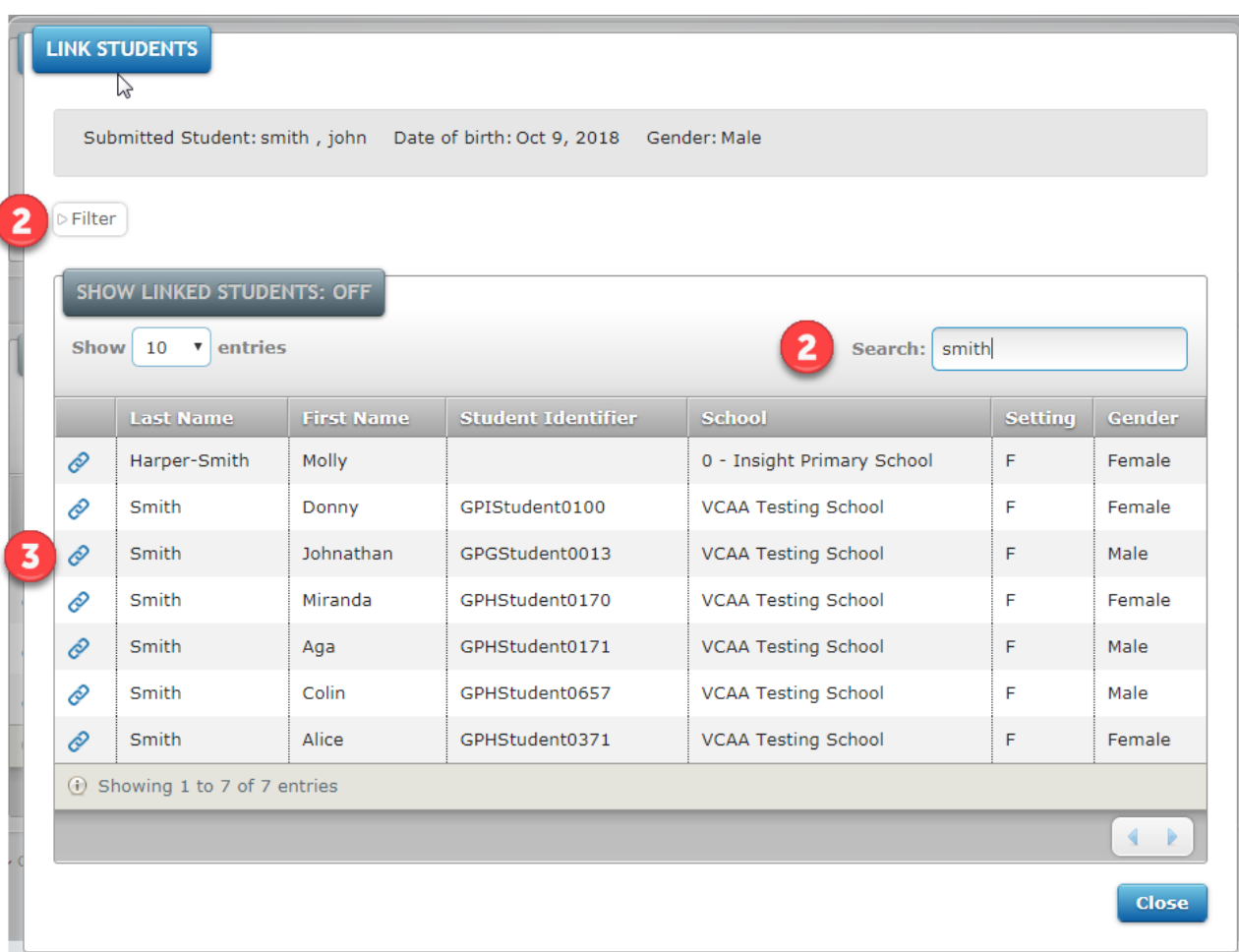

2. A **Link Students** pop-up box will appear. If required, the **Filter** or **Search** functions can be used to find the student (see Figure 2.5).

3. Select the **Link** button, as shown in Figure 2.5. The selected student has now been linked to the TLDS and the pop-up box can be closed.

**Tip:** Student names do not need to match to successfully link a statement to allow for variances, for example John and Johnathan.

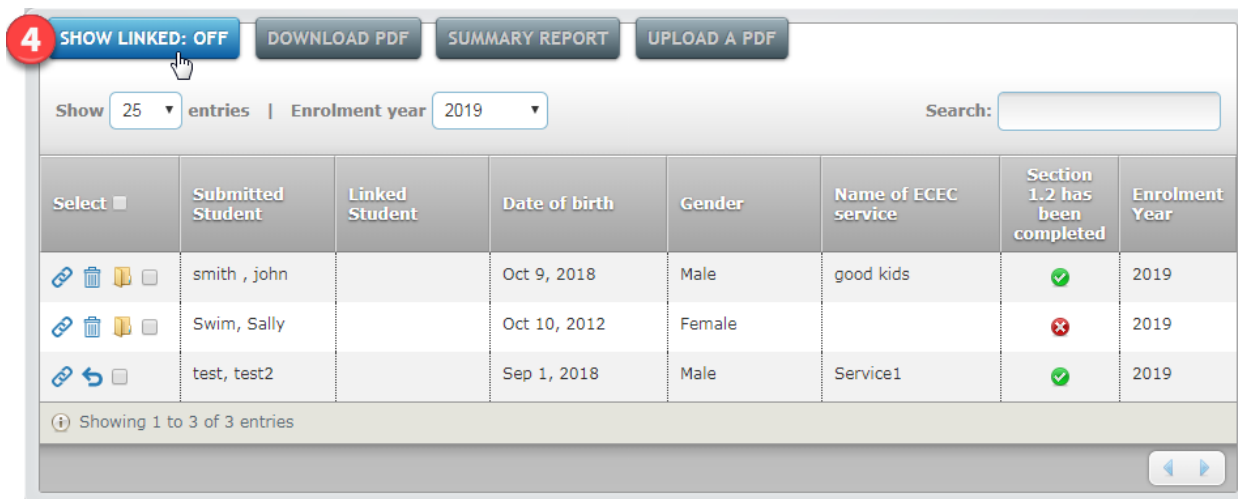

4. The default view of the **TLDS Manager** shows only all unlinked statements. To see all linked and unlinked statements, select **Show Linked: Off** (see Figure 2.6).

## Returning a TLDS

If a TLDS has been submitted to your school in error, or if it has been confirmed that the student will not be attending your school, the TLDS can be returned to the early childhood centre via Insight. This can only occur if the TLDS has not been linked to a student record.

To return a TLDS:

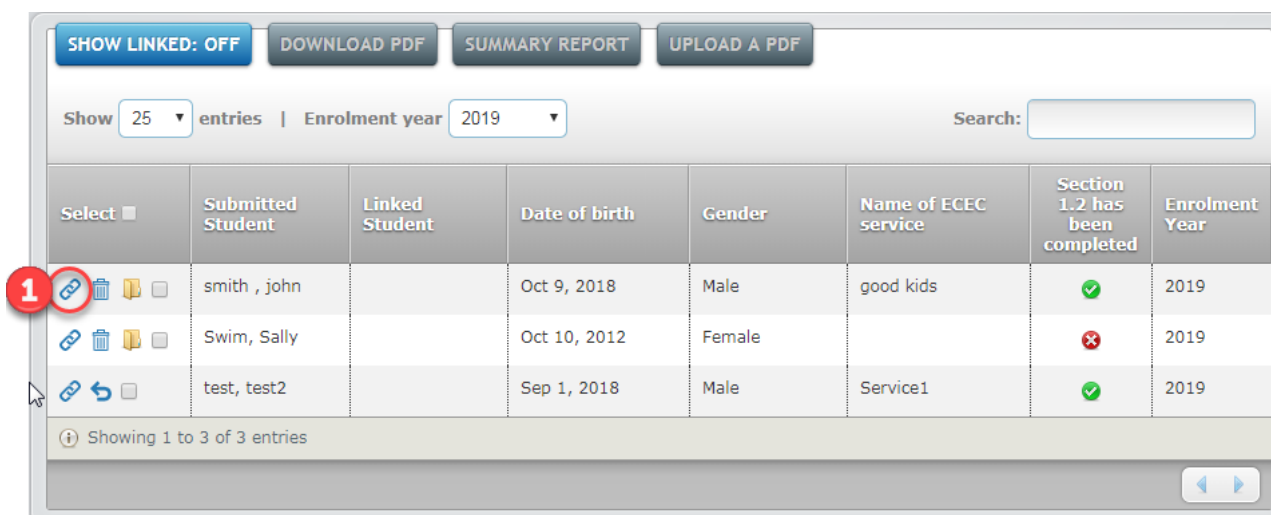

1. In the **TLDS Manager**, ensure the TLDS is not linked to a student. An unlinked TLDS is by the icon in Figure 2.7.

2. If the TLDS has been linked to a student, select the **Unlink** button, as shown in Figure 2.8.
3. Select the **Return** button, as shown in Figure 2.8.
4. A **Return Statement** pop up-box will appear. Enter a reason for returning the statement to the early childhood centre. The reason will be shown to the early childhood centre.
5. Select the **Return** button.

Once the TLDS has been returned to the early childhood centre, the centre will receive an email notification and the TLDS will no longer appear in your school’s TLDS Manager.

## Recalled TLDS

As an Insight School Administrator, you will receive an email notification if an early childhood centre recalls a TLDS they have submitted to your school. An early childhood service may recall a TLDS if they have submitted it to the wrong school or they wish to add further details to the TLDS.

A TLDS that has been linked to an Insight student profile is unable to be recalled by the early childhood service.

## Downloading a TLDS

Completed TLDSs are able to be downloaded from the TLDS Manager page as a PDF. This will allow you view the TLDS details and, if required, print the TLDS.

To download a TLDS:

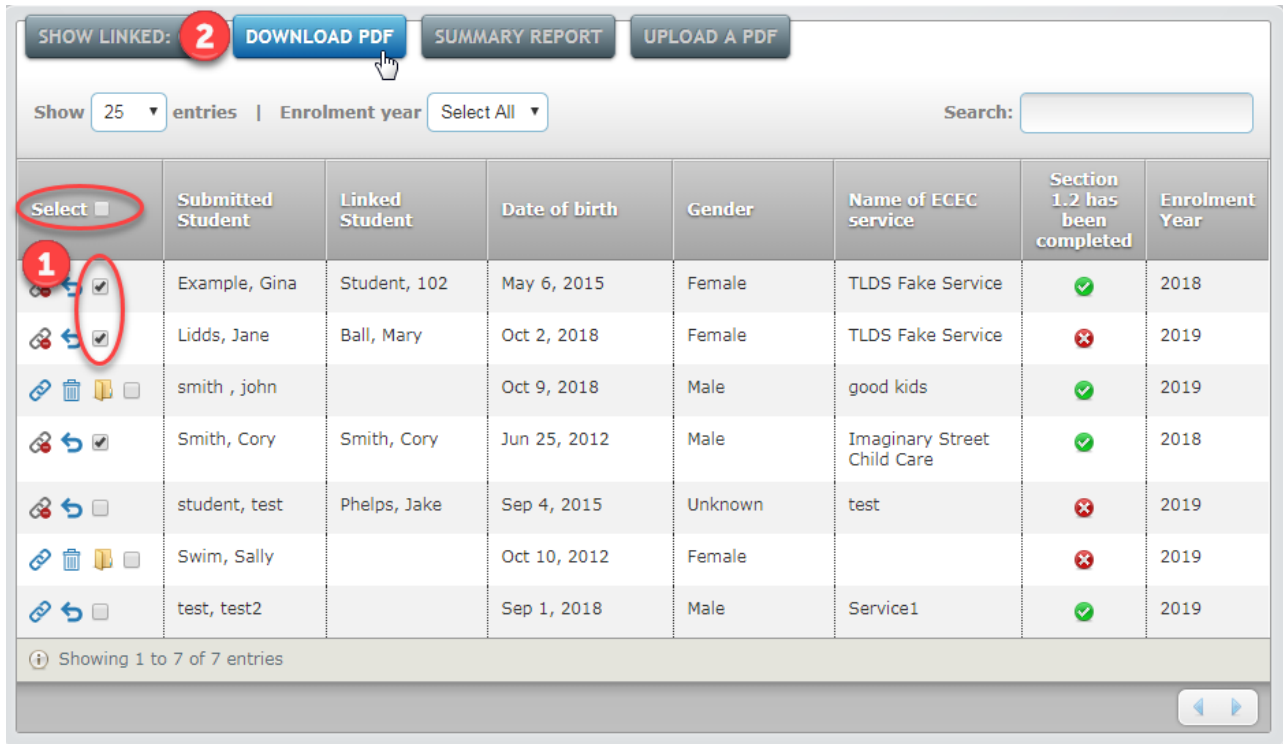

1. In the **TLDS Manager**, select the tick box next to one or multiple student names as required, as shown in Figure 2.9. To download all TLDSs, select the tick box in the header.
2. Select **Download PDF**.
3. A **Download PDF** pop-up box will appear.

4. Select, **Create PDF** as shown in Figure 2.10.

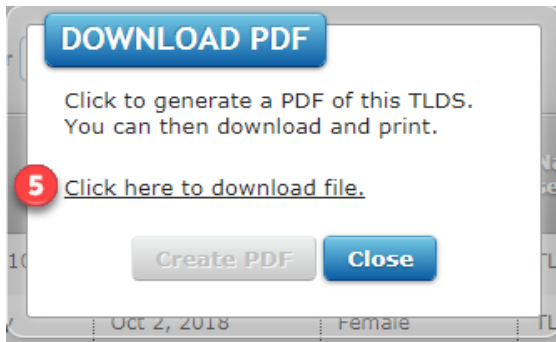

5. Once the files have been generated, select **Click here to download file** as shown in Figure 2.11.
6. A zip folder will then be downloaded. The TLDS(s) will be located in the zip folder as individual PDF files.

## Creating Summary Reports

Summary Reports can be generated for TLDSs that are either linked or unlinked to an Insight student profile.

These reports contain the following details:

- Student name on TLDS
- Linked student name (if applicable)
- Date of birth
- Gender
- Name of early childhood service
- If Section 1.2 has been completed
- Enrolment year.

To generate summary reports:

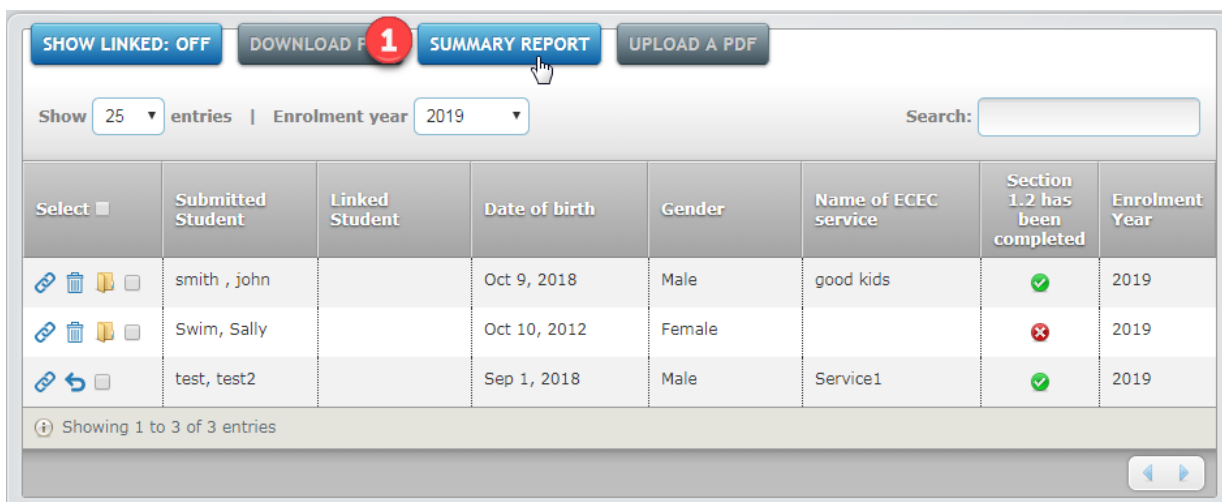

1. In the **TLDS Manager**, select **Summary Report** as shown in Figure 2.12.
2. A **Summary Report Print** pop-up box will appear.

3. Select **Create PDF**, as shown in Figure 2.13.

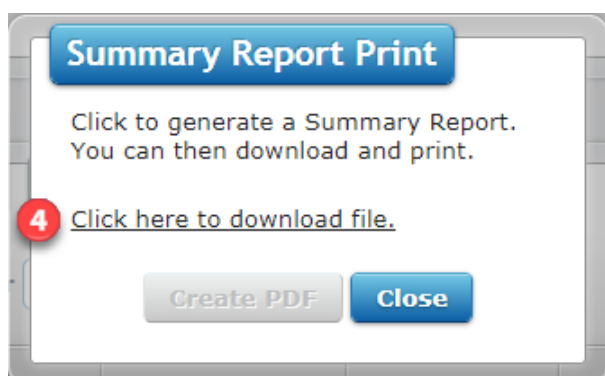

4. Once the files have been generated, select **Click here to download file** as shown in Figure 2.14.
5. A zip folder will then be downloaded. Two PDF documents are located in the zip folder: a summary report for linked TLDS and a summary report for unlinked TLDS.

## Section 3 – TLDS for Teachers

### Accessing TLDS

Teachers are able to view any linked TLDS for students in their class via Insight. A TLDS will not be able to be accessed if it has not been linked to a student's Insight profile by your Insight School Administrator.

To download and view a student's TLDS:

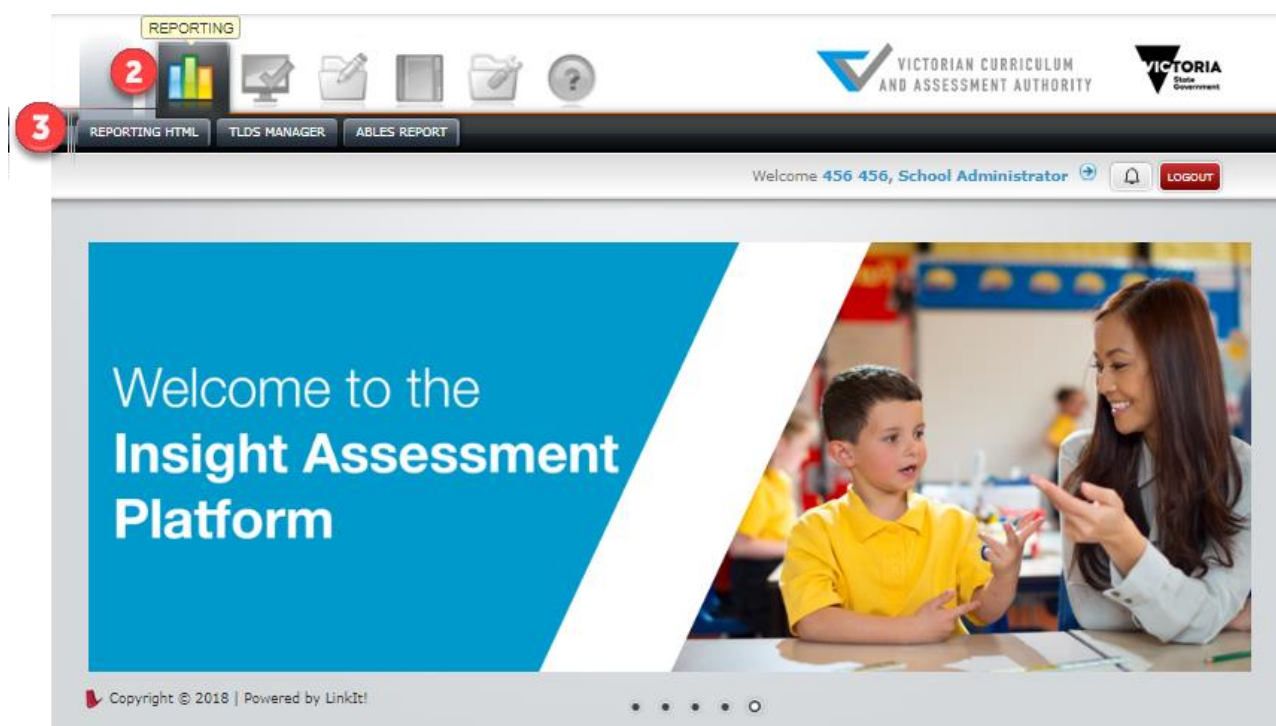

1. Once you have logged in to Insight, you will see the home page as shown in Figure 3.0.
2. Select **Reporting**, as shown in Figure 3.0.
3. Select **Reporting HTML**, as shown in Figure 3.0. The reporting dashboard will open.



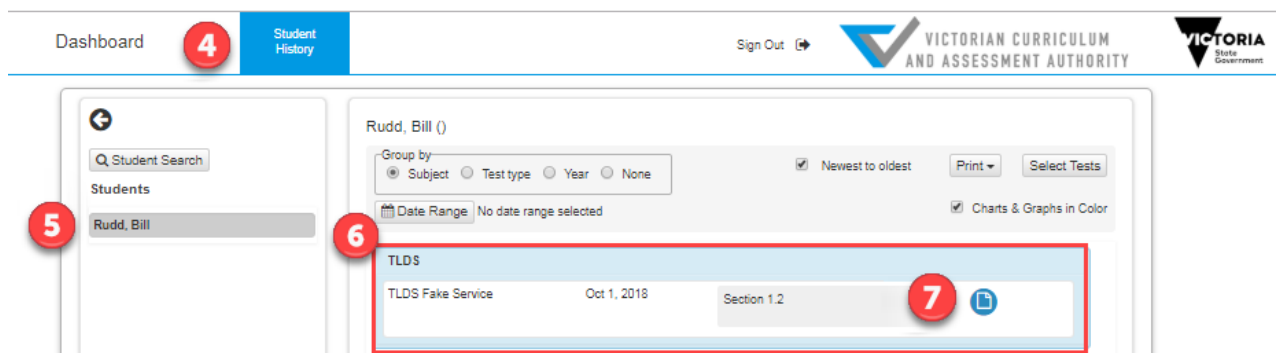

4. Select **Student History** from the top menu, as shown in Figure 3.1.
5. Select a student name from the list on the left-hand side.
6. If the student has a linked TLDS, it will appear under **TLDS**, as shown in Figure 3.1.
7. Select the blue document **Open Report** icon, as shown in Figure 3.1.
8. A new window will open to display the PDF version of the statement, which you can print or save as required.

## Manually uploading a TLDS

As a teacher, you may receive a TLDS via email or as a hard copy from a student's parents/guardians or an early childhood centre. These TLDSs can be manually uploaded to Insight by your school's Insight School Administrator (see page 4). Once an Insight School Administrator has linked the TLDS to a student's Insight profile, it will be visible in reporting if you are the student's classroom teacher.
