Question 8 (10 marks)

There have been a number of deaths and health incidents as a result of people taking illegal pills at many recent music festivals.

The argument for pill testing at festivals is prominent in many communities across Australia. Many people support pill testing because it may protect people and save lives. Others disagree, arguing that the rights of people are being infringed upon and that pill testing may lead to increased drug use.

A music festival is to be held in a coastal community. The music festival committee plans to pilot a pill testing program for festival-goers. The community development worker nominated to assist with the program has values that differ from those of the advocates of the pill testing program.
